Trending News

Following successful campaigning by CILEX, Parliament has now modernised the process of creating and registering Lasting Powers of Attorneys (LPAs) by introducing a new law bridging the gap between solicitors and legal executives. The Powers of Attorney Act 2023 was passed by Parliament in September 2023, which now allows CILEX Lawyers to certify copies of LPAs for the first time in history.

Professor Chris Bones, CILEX Chair, said, "This latest legislative change not only brings the LPA process into the modern digital age but also finally allows our members to certify copies of powers of attorney which they can create in the first place. It reflects the Government's recognition of the important role CILEX has to play in the justice system and the specialist skills our members bring to consumers".

Why is this important?

This is an important milestone that has been reached in our legal profession, which will undoubtedly make document certification more efficient. Our team will benefit from this development and make our certification process more streamlined.



Private Client FAQ's

When can a Lasting Power of Attorney be used?

There are two types of LPAs:

Property and Financial Affairs: This covers all decisions concerning managing finances. The Property and Financial LPA can be used in two instances: when you lose capacity or when you can authorise your Attorneys to make decisions on your behalf even if you still have capacity if it is more convenient to do so. It includes arrangements for investments, cash withdrawals, payment of bills and the sale of property.

Health and Welfare: This covers all health and social care decisions. Unlike the financial decisions LPA, it can only be used when you have lost capacity. It includes considerations such as where you might live, day-to-day care, consent to medical treatment and assessment arrangements.

Without an LPA, your loved ones must apply to the Court of Protection to seek permission to manage your affairs on your behalf, which is known as a Deputyship Order. This can be a costly and emotional process. Although we can guide them through the application, the best solution is to prevent this scenario entirely by making a Lasting Power of Attorney.


